





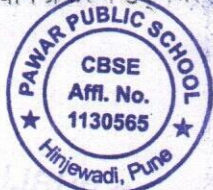

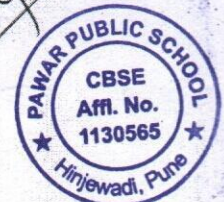
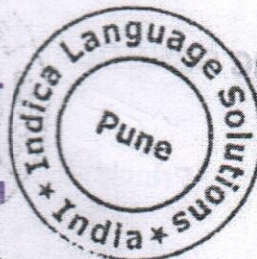
With reference to your application dated 6/3/2023 and on the basis of subsequent correspondence with the school, inspection of the school, I **Education Officer (Primary), Pune Zilha Parishad, Pune** hereby grants provisional recognition to Pawar Public Charitable Trust, 15 J. N. Heredia Road, Ballard Estate, Mumbai -01 Pawar Public School, Hinjewadi, Pune UDISE Number 27251006826 (Non Granted English CBSE medium )for Class 1<sup>st</sup> to Class 8<sup>th</sup> for the period from date 1<sup>st</sup> April 2022 to date 31<sup>st</sup> March 2025.

**The above recognition is subject to compliance of following conditions:**

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize or affiliate beyond Class VIII.
2. The school shall abide by the provisions of the Childrens Right to Free and Compulsory Education Act, 2009 (Annexure I) and the Maharashtra Childrens Right to Free and Compulsory Education Rules, 2011 (Annexure II).
3. The school shall admit in class I, to the extent of 25 % of the strength of that class, children from weaker sections and disadvantaged groups in the nearby area and provide them free and compulsory elementary education till its completion. But however, that in case of pre-primary standards also, this norm shall be followed.

4. For the children referred to in paragraph 3, the school shall be reimbursed as per section 12 (2) of the Act. To receive such reimbursements school shall be provided with a separate bank account.
5. The institute / school shall not collect any capitation fee and shall not subject the child or his or her parents or guardians to any screening procedure.
6. No child shall be denied admission to school to any child for lack of age proof, religion, caste or race, place of birth or any of these reasons.
7. (One) No child admitted in school shall be held back in any class or expelled from school till the completion of elementary education in the school.  
(Two) No child shall be subjected to physical punishments or mental harassment.  
(Three) No child is required to pass any board examination till the completion of elementary education.  
(Four) Every child completing elementary education shall be awarded a certificate as laid down under Rule 23.  
(Five) Students with disabilities /special needs shall be included as per provision of the Act.  
(Six) Teachers possessing the minimum qualification as laid under section 23 (1) of the Act shall be appointed. Moreover, that the teachers who do not hold the minimum qualification on the date of commencement of this Act will have to acquire such minimum qualifications within a period of five years.  
(Seven) The teacher shall perform his or her duties specified under section 24(1) of the Act.  
And  
(Eight) The teachers shall not engage himself or herself in private tuition activities. The school shall ensure this.
8. The school shall follow the syllabus prepared on the basis of curriculum prescribed by the appropriate authority.
9. The school shall admit students in proportion to the facilities available in the school as prescribed in the section 19 of the Act.
10. The school shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as follows-

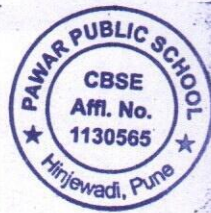
